Several scenarios were provided to the Committee as examples of how the annual payment to CalPers can be smoothed using trust contributions. Analysis of the impact on the long-term financial plan was requested and it was agreed that an annual review of the trust policy, payments, and impact on the long-term plan should be included in the budget process. An analysis of the advantage and/or effect of paying down the UAAL with CalPers directly is also to be included. A draft of the Master Fee Schedule update is being reviewed by department heads and was provided to the Committee. Parking and Business Licenses are not included in this update but will be reviewed prior to the FY2017-18 budget.

- 2. First Quarter Budget Amendment Amendment items would include cleaning up position titles, pay ranges to match the MOUs, carry forward of capital projects, and new grants. It was suggested that a comprehensive update at mid-year similar to how prior year actions were taken would be preferred unless actions were necessary at this time. Budget amendments will be presented to the Finance Committee for review prior to being recommended to City Council.
- 3. Lease Requests/Proposals
  Several new lease requests are pending staff review including small cell sites by
  Verizon and an extension for the Cruising Club. Additional information will be brought
  when reviews are complete.
- 4. Administrative Services Director Report
  Melanie Purcell provided updates on the Administrative Analyst and Business Manager
  positions, the audit kick-off, the CoP Oversight Committee review of invoices, the Solid
  Waste Franchise renewal, the Traklt planning and permitting software, and the proposal
