3. DESIGN REVIEW PERMIT AND ENCROACHMENT AGREEMENT – BRACH RESIDENCE, 112 MARION AVENUE (DR-EA 16-012)

DESCRIPTION: Design Review Permit to allow a 946 square foot addition to the existing 1,329 square foot single-family residence and seeking a recommendation for City Council approval of an Encroachment Agreement for a 154 square foot addition to the existing car deck located in the public right-of-way. The project will expand the existing residence near the front and rear of the parcel for the addition of a master suite, two bedrooms, bathrooms, laundry room, one additional on-site parking space, construct terraced retaining walls and other related site improvements.

DESCRIPTION: Zoning Ordinance Amendments to modify the Emergency [Homeless] Shelter provisions in Sausalito Municipal Code Section 10.28.080. Specifically, the amendments being considered include:

- Amendment to Sausalito Municipal Code Section 10.28.080.D.2 to increase the shelter capacity from a maximum of 20 beds to a maximum of 23 beds.
- Amendment to Sausalito Municipal Code Section 10.28.080.I.2 to decrease the maximum length of stay from 90 days in a 365-day period to 30 days in a 365-day period.

RECOMMENDATION: Adopt the draft resolution recommending City Council adoption of the Zoning Ordinance amendment to increase the shelter capacity from a maximum of 20 beds to a maximum of 23 beds.
