The City Council will hold a public hearing on the following project.

PROJECT DESCRIPTION

Appeal of a Planning Commission decision denying a Design Review Permit, subject to Heightened Design Review, for substantial demolition and remodel of the existing two-unit residential dwelling (446/448 Sausalito Blvd.) and construction of a new 2,352 square foot single-family residential dwelling (77 Crescent Ave.); a Tree Removal Permit for the removal of three protected trees and six heritage trees; a Parcel Map and Condominium Conversion Permit to convert the property into a three-unit condominium covenant; and a recommendation for City Council approval of an Encroachment Agreement for improvements in the public right-of-ways fronting 446/448 Sausalito Boulevard and 77 Crescent Avenue. David Holub, applicant/property owner, appealed the December 15, 2016 Planning Commission decision. At the City Council meeting of January 24, 2017, the City Council will conduct a public hearing on the appeal.
