NOTICE OF PLANNING COMMISSION PUBLIC HEARING FOR A DESIGN REVIEW PERMIT TO CONSTRUCT A NEW 2,471 SQUARE FOOT SINGLE-FAMILY HOME; A TREE REMOVAL PERMIT TO REMOVE AND REPLACE 7 PROTECTED OAK TREES; AND DETERMINATION OF A CITATION FEE FOR ALTERATIONS TO A PROTECTED TREE WITHOUT A PERMIT AT 168 SANTA ROSA AVENUE (DR/TRP 15-355)

YOU ARE INVITED TO ATTEND A PLANNING COMMISSION PUBLIC HEARING ON THE FOLLOWING PROJECT:

PROJECT DESCRIPTION Ray Cassidy, on behalf of the property owner Martin Coyne, is requesting a Design Review Permit to construct a 2,471 sf, three-level, single-family dwelling on an undeveloped parcel with a 441 sf attached garage, and two rear rooftop decks at 168 Santa Rosa Avenue (APN 065-112-33). Landscape improvements include creating a flat rear yard with perimeter retaining walls and large perimeter landscaping. The applicant is also seeking a Tree Removal Permit to remove 7 protected trees from the site and provide 12 replacement trees. The Planning Commission will also review a citation fee set by the Enforcement Officer for alteration to a protected tree without a permit. This is the third public hearing for this project following hearings on May 6 and July 11, 2016.
