

## CITY OF SAUSALITO NOTICE OF PLANNING COMMISSION PUBLIC HEARING FOR A DESIGN REVIEW AND ACCESSORY DWELLING UNIT PERMIT APPLICATION AT 97 SANTA ROSA AVENUE (DR-ADU 16-345)

You are invited to attend a Planning Commission public hearing on the following project:

PROJECT DESCRIPTION

Nora Frei, on behalf of property owners Robert Massey, Massey Revocable Trust, et al., is requesting approval of a Design Review Permit, subject to heightened design review, and an Accessory Dwelling Unit Permit for the remodel of an existing 2,328 square-foot, single-family residence. The proposed remodel would add 288 square feet to the residence, create an accessory dwelling unit on the basement floor, create a detached, single-car garage adjacent to the accessory unit, and increase the height of the home from 28'-9.5" to 31'-5".
