1 DECLARATION OF ALEXANDER L. MERRITT

2 I, Alexander L. Merritt, declare as follows:

3 1. I am an attorney duly admitted to practice before this Court. I am an  
4 associate with Sheppard, Mullin, Richter & Hampton LLP, attorneys of record for Petitioner and  
5 Plaintiff City of Sausalito.

6 2. If called as a witness, I could and would competently testify to all facts  
7 within my personal knowledge except where stated upon information and belief.

8 3. This declaration is submitted in support of Petitioner's Opposition to Special  
9 Motion to Strike SLAPP Suit.

10 4. Attached as Exhibit A is a true and correct copy of the "Summary of  
11 Recommendations," from the District's Building and Operating Committee/Committee of the  
12 Whole ("Building Committee") to the District's Board of Directors ("Board") for its November  
13 18, 2016 meeting, which I printed on March 20, 2017 from


1 associated with prolonged reviews of the Sausalito terminal design; and to provide funding needed  
2 to complete the remaining work for the Sausalito and San Francisco facilities, specifically  
3 including “reviewing, preparing and completing environmental studies and reports; assisting and  
4 participating in required public outreach; assisting in obtaining all required permits; finalizing  
5 designs; preparing bid documents for construction contracts; and other associated services.”

### Recommendation

The Building and Operating Committee recommends that the Board of Directors approve actions relative to the Professional Services Agreement (PSA) No. 2010-FT-3, *Conceptual Designs, Environmental Studies and Engineering Services for Modifications and Improvements to the Larkspur, San Francisco, and Sausalito Ferry Terminal Facilities*, with Moffatt & Nichol as follows:

1. Authorize execution of Amendment No. 5 to the PSA No. 2010-FT-3 in the not to exceed amount of \$3,354,000, for the increased scope of design services, for the total not to exceed authorized PSA amount of \$9,884,525; and,
2. Authorize an increase in the amount of \$3,354,000 in the FY 16/17 Ferry Transit Division Capital Budget for the Gangway & Piers - Design Project (Project #0503), to be funded with \$2,683,200 Federal Transit Administration (FTA) grant funds (80%) and \$670,800 from District reserves (20%), for a revised total Project budget of \$11,728,525, subject to the concurrence of the Finance-Auditing Committee.

This matter will be presented to the Finance-Auditing Committee at its November 17, 2016 meeting and to the Board of Directors for appropriate action at its November 18, 2016 meeting.

### Summary

The Larkspur Ferry Terminal, San Francisco Ferry Terminal, and Sausalito Ferry Landing passenger boarding facilities are at the end of their useful life and are in need of replacement. The Golden Gate Bridge, Highway and Transportation District (District) has been developing projects

to replace these facilities with new boarding facilities that will provide more efficient and comfortable loading and disembarking of the vessels for passengers, including bicyclists and passengers with limited mobility. The new boarding facilities will include new ramps, ferry slips/floats, and other terminal improvements, all of which will be designed to follow applicable Americans with Disabilities Act (ADA) regulations and guidance documents, as well as the United States Access Board's pending *Passenger Vessel Accessibility Guidelines*.

The need for the project was identified in 2005. The District then pursued federal funds to finance the project's initial study, environmental evaluation and final design. By Resolution No. 2009-077, the Board of Directors authorized execution of a Professional Services Agreement, PSA No. 2010-FT-3, *Conceptual Designs, Environmental Studies and Engineering Services for Modifications and Improvements to the Larkspur, San Francisco, and Sausalito Ferry Terminal Facilities*, to Moffatt & Nichol, to evaluate the existing terminals, develop conceptual designs for the new passenger boarding systems, perform necessary environmental studies associated with the conceptual designs, assist the District in obtaining all necessary permits, and prepare final design and construction bid documents for the new terminal facilities. By Resolution No. 2013-116, the Board of Directors authorized execution of Amendment No. 2 to PSA 2010-FT-3 for additional design services consisting of design of modifications to the ferry vessel doorways to provide for uniform means of loading and unloading the vessels at the improved terminals, and the design of a temporary ferry landing to accommodate ferry operations during construction of modifications to the permanent Sausalito Ferry Terminal facilities.

The District has completed the evaluations, conceptual designs and environmental studies associated with the Sausalito Ferry Landing in conformance with the California Environmental Quality Act (CEQA) and National Environmental Policy Act (NEPA). On December 14, 2012, the Board, by Resolution No. 2012-100, adopted a Mitigated Negative Declaration in conformance with CEQA and approved the preferred design alternative for this terminal. On February 13, 2014, the Federal Transit Administration (FTA) adopted a documented Categorical Exclusion in conformance with NEPA. Construction permit applications for the Sausalito facility have been submitted to the Regional Water Quality Control Board (Water Board), the Bay Conservation Development Commission (BCDC) and the U.S. Army Corps of Engineers. On September 12, 2014, the District received the Water Board certification for the project construction. At the December 4, 2014 BCDC public hearing for the project permit, the City of Sausalito raised objections to the project and requested that BCDC not issue the permit until the District and the City reach an agreement on the project.

Even though the project was already environmentally cleared, in the spirit of cooperation, the District agreed voluntarily to participate in the City of Sausalito's public review process. At the request of the City of Sausalito, the District and its consultant have produced additional plans and renderings of the project, have participated in numerous public meetings, have responded to questions from City of Sausalito staff and residents concerning the project, and have made modifications to the project design. This additional work was outside the consultant's original scope of services and has resulted in a depletion of the project budget. Additional funds are necessary to support resolution of issues that hinder the start of the Sausalito Terminal construction, complete the design and bid documents for the Sausalito site, and complete environmental studies and design for the San Francisco site.



The prolonged reviews of the Sausalito terminal design have resulted in delays to project development for all three facilities and additional costs associated with the delays. For instance, some of the environmental studies, technical reports and regulatory agency consultations performed with respect to the proposed San Francisco facility have been completed, but, due to the passage of time, they must now be re-evaluated. Also, in light of the current developments being considered by the Port of San Francisco along the San Francisco waterfront and the concerns regarding sea level rise and its potential impacts on the new facilities, an additional scope of environmental reviews and technical studies will be required for the San Francisco and Larkspur Terminals.

Engineering staff requested that the consultant provide a cost estimate to complete the remaining work at the Sausalito and San Francisco facilities, including the following tasks: reviewing, preparing and completing environmental studies and reports; assisting and participating in required public outreach; assisting in obtaining all required permits; finalizing designs; preparing bid documents for construction contracts; and other associated services. Engineering staff has negotiated scope of work and cost proposal in the amount of \$3,354,000 with the consultant for these additional services. Engineering staff will bring to the Board, at a later date, an estimate of cost necessary to complete environmental studies and design for the Larkspur Ferry Terminal.

Staff has determined that the negotiated price is reasonable based on the scope of work, previous cost data for similar design services, and cost data for design services provided by consultants for other Ferry Division projects. The consultant will be compensated for actual time expended and expenses incurred plus a fixed fee, up to the not to exceed authorized amount.

Staff recommends that the Building and Operating Committee recommend that the Board of Directors authorize execution of the Fifth Amendment to Contract No. 2010-FT-3, and an increase in the project budget as outlined in this report.

### **Fiscal Impact**

On September 25, 2009, by Resolution No. 2009-077, the Board of Directors authorized execution of a Professional Services Agreement, PSA No. 2010-FT-3, *Conceptual Designs, Environmental Studies and Engineering Services for Modifications and Improvements to the Larkspur, San Francisco, and Sausalito Ferry Terminal Facilities*, to Moffatt & Nichol, in the not to exceed amount of \$6,000,000, and established a project budget in the amount of \$7,844,000. On December 20, 2013, by Resolution No. 2013-116, the Board of Directors authorized execution of Amendment 2 to PSA 2010-FT-3 in the amount of \$530,525, and a capital budget increase in the same amount for a total authorized PSA amount of \$8,374,525. With the approval of this Fifth Amendment in the not-to-exceed amount of \$3,354,000, the total authorized PSA amount will be increased to \$9,884,525. A capital budget increase in the amount of \$3,354,000 to be funded with \$2,683,200 FTA grant funds and \$670,800 from District reserves will be required to fully fund this project at the proposed total budget of \$11,728,525 which will consist of \$9,382,820 Federal Transit Administration (FTA) grant funds, \$2,004,622 District funds, and \$341,083 State Transportation Improvement Program grant funds (80% FTA / 17% District / 3% State).

### Background

Following the BCDC December 4, 2014 hearing, the District met with City of Sausalito staff and agreed to participate voluntarily in a project review process that would allow the City residents and officials to provide additional input on the project design. The District and its consultant submitted project plans and renderings to the City in advance of a Sausalito Historic Landmarks Board and Planning Commission (HLB/PC) Joint study session. On March 11, 2015, the District presented the project during the Sausalito HLB/PC study session. On March 21 and 22, 2015, the District provided a story pole equivalent demonstration between 8:00 AM and 10:00 AM at the project site as requested by the City. On March 24, 2015, the District and its consultant submitted the revised project design documents and additional information to the City based on the comments received from the Sausalito HLB/PC and the public during the study session. The District submitted the project design in the City's preferred public review submittal format. On April 1, 2015, April 15, 2015 and April 29, 2015 Sausalito HLB/PC meetings were held where the District presented the final project design, answered questions, and received the HLB/PC final findings on the project design. On May 5, 2015, the District participated in the City of Sausalito Council meeting during which the City Council voted to not provide consent on the project (which the City contends is required under the lease agreement for the ferry terminal property). On July 9, 2015, the District withdrew its BCDC permit application.

On June 27, 2015, October 10, 2015 and November 14, 2015, the District attended workshops in Sausalito with representatives of the Sausalito City Council and Sausalito residents to further discuss the project. The District and its consultant made changes to the project design based on the input received during these workshops. Project design drawings and photo renderings were revised to reflect the updated project design. On March 2, 2016, the District submitted the updated proposed design to the City of Sausalito to initiate the public review process. The District presented the updated proposed project on to the Sausalito HLB/PC on March 16, 2016 and to the Sausalito Sustainability Commission on March 17, 2016. On March 29, 2016, the District and its consultant participated in another Sausalito HLB/PC meeting and received the HLB/PC findings to the updated proposed project.

Following the public meetings, the City informed the District that they would be performing their own independent peer review of the District's proposed project photo renderings and float size. Between April 2016 and August 2016, the District and its consultant prepared documents, figures, photo renderings, and drawings to inform the City's peer reviewers how the proposed project was designed, how the photo renderings were obtained and to answer the peer reviewers' questions. On August 18, 2016 the District submitted the updated project design to the City requesting a 45-day review process to receive City Council consent on the project. On August 22, 2016, the City requested additional review time. On September 2, 2016, the District withdrew its submittal to the City. On September 13, 2016, the City of Sausalito filed a Petition for Writ of Mandate and Complaint for Declaratory Relief ("Complaint") in Marin County Superior Court. The Complaint asserts causes of action under CEQA and the Public Trust Doctrine and seeks declaratory relief regarding the interpretation of the lease agreement for the ferry terminal property and the City's authority as a "responsible agency" under CEQA. On October 13, 2016, the District filed a motion to transfer the City's lawsuit to a neutral county. The court is scheduled to hear the District's motion on December 7, 2016.

Set forth below is a status report of legal matters Hanson Bridgett has worked on since our last written report of February 15, 2017, to the Board of Directors.

In addition to provision of day-to-day assistance and advice, such as attendance at E-Team, Committee and Board meetings; review of draft minutes and staff reports, resolutions and ordinances; and, assistance with on-going personnel and labor relations matters, our time has been devoted to assisting the District and its operating divisions with the following specific matters:

*District:*

- Technology Contracts: Attention to multiple technology related contracts, including printer services, Citrix and Microsoft, and VMWare and Microsoft consultant services.
- On-Line Solicitation Management System: Review and revise Request for Proposals and provide feedback to District staff.
- Website Redesign: Assistance to District staff regarding review of documents and contract negotiation.
- Procurement Streamlining Project: Assistance and advice to District staff regarding District proposed procurement legislation.
- Real Property Matters: Attention to real property-related matters, including legal research and analysis regarding the proposed Tiburon and existing Sausalito ferry operations.
- PEPRA: Attention to application of PEPRA to GGB-ATU Plan participants.
- Labor Negotiations: Continuing efforts regarding the 2017 Labor Negotiations Cycle.
- Public Records Act Requests (General): Review documents and assist in preparing responses to multiple Public Records Act requests.
- Title VI: Assistance to District staff regarding preparation of fare change data analysis for upcoming fare change proposals.

- *Linder v. GGBH&TD*: Continuing defense of state lawsuit brought by former Sgt.'s Office employee after obtaining dismissal of federal lawsuit; and, continued defense of plaintiff's appeal of the federal court's dismissal of his prior case including preparation for oral argument.
