DESCRIPTION

Foxx Imaging, on behalf of Anabi Oil Corporation, is requesting a Sign Permit for business identification, directional, fuel price and miscellaneous information signage at the Shell Service Station on 2901 Bridgeway (APN 063-151-06). The project includes one internally-illuminated Shell Pecten Logo sign to replace the Channel Lettering that spells out "Shell" on the overhead canopy; a complete reface of the 6-foot 5-inch monument sign fronting Bridgeway, modification of the "Enter" and "Exit" Carwash wall signs, refacing five fuel dispenser valences and installing four new fuel dispenser identification flags.
