

**RESOLUTION NO. 5620**

**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF SAUSALITO  
RATIFYING THE MARIN COUNTY REGISTRAR OF VOTERS  
CANVASS OF RETURNS OF THE GENERAL MUNICIPAL ELECTION OF  
NOVEMBER 8, 2016  
AND DECLARING ELECTED THE PERSON RECEIVING  
THE LARGEST NUMBER OF VOTES FOR THE OFFICE**

**WHEREAS**, by Resolution No. 5580 adopted on May 17, 2016, the City Council of the City of Sausalito requested the Board of Supervisors of the County of Marin to render services regarding the General Municipal Election to be held in the City of Sausalito on Tuesday, November 8, 2016, to fill three positions on the City Council; and

**WHEREAS**, the County Clerk did, on December 6, 2016, canvass the vote cast at said election and did transmit to the City of Sausalito a certified copy of the statement of votes cast, which certification is now on file in the office of the City Clerk of the City of Sausalito and attached as Exhibit A.

**NOW, THEREFORE, BE IT RESOLVED** by the City Council of the City of Sausalito that the canvass of votes by the County Registrar of Voters as shown by Certificate of Canvass of Vote is hereby confirmed and approved:

SECTION 1. The whole number of ballots cast in the City of Sausalito at said election is 4,854, including 3,369 Vote by Mail Ballots.

SECTION 2.

- a. The names of the persons voted for at the election for three Members of the City Council for a term of four years are as follows: Ray Withy, Joan Cox, Joe Burns and Sam Ruben.
- b. The number of votes cast for each candidate for Member of the City Council for the term ending November 2020 were as follows:

Joan Cox	2,779
Ray Withy	2,710
Joe Burns	1,659
Sam Ruben	1,508

SECTION 3. That the number of votes given at each precinct and the number of votes given in the City to each of the persons above named for the respective offices for which the persons were candidates are listed in Exhibit B attached.

SECTION 4. The City Council does declare and determine that:

**JOAN COX, RAY WITHY and JOE BURNS** elected as Member(s) of the Sausalito City Council for the term of four (4) years, ending November 2020.

SECTION 5. The City Clerk shall enter in the records of the City Council of the City of Sausalito a statement of the result of the election showing: 1) The whole number of votes (ballots) cast in the City; 2) the names of the persons voted for; 3) that the person with the most votes was elected to the position as Member(s) of the Sausalito City Council; 4) the number of votes cast at each precinct for each candidate; and 5) the total number of votes cast for each candidate.


SECTION 6. The City Clerk shall certify to the passage and adoption of this resolution and enter it into the file of original resolutions.

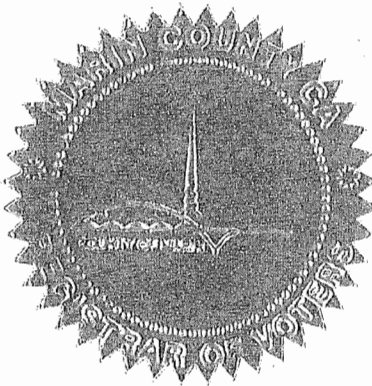
