You are invited to attend a Planning Commission public hearing on the following project.

PROJECT DESCRIPTION

Studio 300A Architecture, on behalf of Dr. Alexander Kashef, is proposing a project that includes renovation of the original Valhalla structure and changes to the building site (201 Bridgeway) to create a total of two residential units on the property (7,901 square feet total floor area). The project requests approval of the following actions by the City:

- Design Review Permit for demolition, renovation, and restoration of the portions of the existing Valhalla structure/site for the creation of two residential units and associated site improvements.
- **Conditional Use Permit** to locate one required parking space for a unit at 201 Bridgeway off-site at 206 Bridgeway.
- Encroachment Agreement for private improvements within the public right-of-ways.
- **Tentative Subdivision Map** to create a separate parcel for the existing single-family residence at 206 Second Street.
- **Environmental Review Addendum** to the Initial Environmental Study/Mitigated Negative Declaration for the previously-approved seven residential condominium units project.
