**AT 2 CRECIENTA DRIVE (DR 16-314)**

**You are invited to attend a Planning Commission public hearing on the following project:**

**PROJECT DESCRIPTION** Heckman Architects, on behalf of property owner Familia De Frijoles, LLC, is requesting a Design Review Permit for the demolition of an existing 1,310 square foot, two-level, single-family residence and construction of a new 4,261 square foot, two-level, single family residence at 2 Crecienta Drive (APN 064-252-11). Landscaping improvements, including terraced retaining walls, are proposed throughout the site. The project includes a newly attached 420 square foot, two-car garage and re-roof of an existing detached 689 square foot, two-car garage. This item is being continued from the July 5 Planning Commission Meeting.
