

## CITY OF SAUSALITO NOTICE OF PLANNING COMMISSION PUBLIC HEARING FOR A DESIGN REVIEW PERMIT, TREE REMOVAL PERMIT, AND AN ENCROACHMENT AGREEMENT AT 220 CURREY LANE

You are invited to attend a Planning Commission public hearing on the following project.

## **DESCRIPTION**

Jazz Builders, Inc., on behalf of the Robert and Josephine Moretto 2011 Living Trust, requests approval of the following items:

- Design Review Permit to construct a 3,969 square-foot, three-level, single-family residence with attached two-car garage and associated improvements at 220 Currey Lane (APN 064-232-12);
- Tree Removal Permit for the removal of 10 protected trees; and
- Encroachment Agreement recommendation to the City Council for driveway, walkways, retaining walls, on-grade stairs, and landscaping improvements in the public right-of-way.

The project entails demolition of the existing 1,032 square-foot, two-level, residential structure on the property (DR-EA-TRP 15-162).
