Petitioner and Plaintiff, the City of Sausalito (City), and Respondent and Defendant/Real Party in Interest, the Golden Gate Bridge, Highway and Transportation District (District) (collectively, the Parties), through their counsel, submit this Stipulation and Proposed Order for Leave to File First Amended Petition (Stipulation) with reference to the following facts:

WHEREAS, on September 13, 2016, the City filed a Verified Petition for Writ of Mandate and Complaint for Declaratory Relief, which included a cause of action alleging that the District violated California's Environmental Quality Act (CEQA) in connection with its proposed Sausalito Ferry Terminal Improvements Project (Project);

WHEREAS, on May 26, 2017, the District authorized implementation of a modified Project and approved an Addendum to the Mitigated Negative Declaration for the Project;

WHEREAS, the City contends that the District's actions in approving the modified Project and Addendum further violated CEQA, and therefore seeks to file an action or proceeding to set aside those actions within the meaning of Public Resources Code section 21167;

WHEREAS, the Parties agree that it is appropriate for the City to file the First Amended Verified Petition for Writ of Mandate and Complaint for Declaratory Relief ("First Amended Petition") submitted concurrently with the Stipulation and Proposed Order, which alleges an additional cause of action for violations of CEQA based on the District's approval of the modified Project and Addendum.

Therefore, the Parties STIPULATE as follows:

- 1. The City shall be granted leave to file the First Amended Petition submitted concurrently with this Stipulation and Proposed Order.
- 2. The First Amended Petition shall be deemed filed and served as of the date this Stipulation and Proposed Order is lodged with the Court, thereby satisfying the requirements of Public Resources Code section 21167.
- 3. The District shall respond to the First Amended Petition within 30 days of the filing and service of this Stipulation and Proposed Order.
