The City Council will hold a public hearing on the following project.

PROJECT DESCRIPTION

On **December 15, 2016**, the Planning Commission denied a Design Review Permit, subject to Heightened Design Review, for substantial demolition and remodel of the existing two-unit residential dwelling (446/448 Sausalito Boulevard), construction of a new single-family residential dwelling (77 Crescent Avenue), and other related site improvements. On **December 27, 2016**, the property owner filed an appeal of the denial of the project. On **January 24, 2017**, the City Council conducted a public hearing to consider the appeal and remanded the project to the Planning Commission to consider revisions to the project and to determine whether the required Design Review Findings for project approval can be made. On **May 31, 2017**, the Planning Commission held a public hearing to consider revisions to the project and determined that the required Design Review Findings for project approval cannot be made. On **July 11, 2017**, the City Council conducted a public hearing to consider the appeal, reviewed the Planning Commission's determination, and continued the public hearing for further consideration. On **September 11, 2017**, the City Council will conduct a public hearing to consider the appeal.
