PROJECT DESCRIPTION

Ted Horton, on behalf of property owner SASP, LLC, is requesting approval of a Design Review Permit, subject to Heightened Design Review, at 86 San Carlos Avenue, a Noteworthy Structure listed on the Historic Resources Inventory, to add 1,497 square feet of subterranean floor area and 8 square feet of aboveground floor area; remodel the exterior with new doors, windows, cladding and skylight; and install an elevator shaft.
