



## CITY OF SAUSALITO NOTICE OF PLANNING COMMISSION AND HISTORIC LANDMARKS BOARD PUBLIC HEARING FOR A DESIGN REVIEW PERMIT, SIGN PERMIT, AND ENCROACHMENT AGREEMENT AT 777 AND 801 BRIDGEWAY- CASA MADRONA HOTEL & SPA

### PROJECT DESCRIPTION

Weir | Andrewson Associates, Inc., on behalf of Casa Madrona Hotel & Spa, LLC, requests approval of the following items concerning the structures located at 777 and 801 Bridgeway within the Downtown Historic District (APNs 065-063-45, 065-063-46) (DR-SP-EA 17-161):

- Design Review Permit for exterior modifications including painting, landscaping, sidewalk paving, signage, and updating fixtures, to the Casa Madrona Hotel & Spa structures located within the Downtown Historic District;
- Sign Permit for business identification signage; and
- Encroachment Agreement for entry awning, landscaped planters, and balcony guardrails.
