1. DUNPHY PARK – IMPROVEMENTS TO DUNPHY PARK (DR 17-116)

**DESCRIPTION:** The City of Sausalito is requesting approval of a Design Review Permit for proposed improvements to Dunphy Park to enhance the design and use of the park. The project includes new landscaping, tree removal and planting of new trees, a new restroom facility, new picnic areas, new observation decks, redesign and replacement of the volleyball and bocce ball courts, grading work, and parking reconfiguration.

**RECOMMENDATION:** Approval, subject to conditions.

2. 2901 BRIDGEWAY / SP FOR SHELL STATION SIGNAGE (SP 15-167) Staff: David Chursenoff

**DESCRIPTION:** Foxx Imaging, on behalf of Anabi Oil Corporation, is requesting a Sign Permit for business identification, directional, fuel price and miscellaneous information signage at the Shell Service Station on 2901 Bridgeway (APN 063-151-06). The project includes on internally-illuminated Shell Pecten Logo sign to replace the Channel Letters that spells out "Shell" on the station's overhead canopy; a complete reface of the 6-foot 5-inch monument sign fronting Bridgeway; modification of the "Enter" and "Exit" Carwash wall signs; refacing five fuel dispenser valences and installing four new fuel dispenser identification flags.

**RECOMMENDATION:** Approval, subject to conditions.

3. STUDY OF BANKS/FINANCIAL SERVICES, RETAIL USES IN THE COMMERICAL RESIDENTIAL (CR) ZONE

Staff: David Chursenoff

**DESCRIPTION:** The City Council adopted an interim urgency ordinance imposing a moratorium on the issuance of occupancy use permits for "banks and financial services, retail" uses in the CR zone. The City Council has directed the Planning Commission to study the impacts of "banks and financial services, retail" uses in the CR zone, specifically if "banks and financial service, retail" uses should be removed as a permitted use, determine if the definition of "banks and financial services, retail" should be modified, determine if a Minor Use Permit or Conditional Use Permit should be required for such uses in the CR zone, consider a zoning ordinance amendment, or any other recommendations. This study session will evaluate Staff recommendations that have been based on guidance provided at the previous study session on 2/8/17.

**RECOMMENDATION:** Conduct a study session.
