

CITY OF SAUSALITO NOTICE OF PLANNING COMMISSION AND HISTORIC LANDMARKS BOARD PUBLIC HEARING FOR A DESIGN REVIEW PERMIT AND ENCROACHMENT AGREEMENT FOR THE CONVERSION OF FOUR PUBLIC PARKING SPACES ON THE WEST SIDE OF THE BRIDGEWAY PUBLIC RIGHT-OF-WAY BETWEEN 621 AND 633 BRIDGEWAY WITHIN THE DOWNTOWN HISTORIC DISTRICT INTO A PARKLET ("BRIDGEWAY PARKLET")

You are invited to attend a Planning Commission and Historic Landmarks Board public hearing on the following project (DR-EA 16-343).

PROJECT DESCRIPTION

In May 2014, the Community Development Director approved the temporary conversion of four public parking spaces on the west side of the Bridgeway public right-of-way between 621 and 633 Bridgeway (APNs 065-132-01, -02, and -03) within the Downtown Historic District into a parklet for dining tables and chairs for use by the patrons of the adjacent four food establishments (Angelino Restaurant, Venice Gourmet, Venice Pizzeria, and Bridgeway Café) (CDD 13-117).

In January 2016, the City Council authorized the extension of Permit CDD 13-117 for one year, until January 2017, with the condition that any continued parklet use at this site for a longer duration requires submittal of a formal Design Review Permit and Encroachment Agreement application for review and consideration by the City.

In January 2017, applicant Mike Monsef submitted a Design Review Permit and Encroachment Agreement application for review and consideration by the City. The project proposes to maintain the parklet in the existing configuration and design with the improvement of replacing the existing wood surface area with a concrete surface area.
