### AGENDA TITLE:

### SUMMARY & BACKGROUND

Seventeen (17) candidates applied to be considered for appointment to the Planning Commission during our last round of vacancies.

- Since May 20, Council has conducted interviews of sixteen of those applicants and filled three positions.
- Before the Closed Session on September 16, Council will interview the final Planning Commission applicant, Stafford Keegin.

Council must now appoint one position to the unexpired term which has been held by Janelle Kellman and will expire in May 2010.

### STAFF RECOMMENDATIONS

Appoint one applicant to fill the Planning Commission vacancy with a term expiring in May, 2010.




