# 3. MARIJUANA REGULATIONS / CITY-WIDE / ZONING ORDINANCE AMENDMENT / ZOA 17-390

**DESCRIPTION:** Zoning Ordinance Amendments to amend Title 10 Zoning Section 10.44.320 of the Sausalito Municipal Code and add Chapter 10.47 Marijuana Regulations to prohibit the commercial cultivation and sale of all marijuana; prohibit the delivery of all marijuana, including medical marijuana; and prohibit the outdoor cultivation of all marijuana.

**RECOMMENDATION:** Adopt draft resolution.

# 4. ACCESSORY DWELLING UNIT REGULATIONS / CITY-WIDE / ZONING ORDINANCE AMENDMENT / ZOA 17-390

**DESCRIPTION:** Zoning Ordinance Amendments to amend Title 10 Zoning Chapter 10.44 (Specific Use Requirements) Section 10.44.080 Accessory Dwelling Unit Regulations of the Sausalito Municipal Code to bring the regulatory requirements into compliance with recent State law.

**RECOMMENDATION:** Adopt draft resolution.

- Staff shall review the height section to determine the best way to retain flexibility in the design with minimum height for the ministerial approvals.
- It is strongly urged that the City Council direct staff to monitor the impact of the 16-foot wide zones on the City's ability to produce and meet its Housing Element goals.
- No Building Code fire safety requirements should be reduced. The Building Department should determine if it is possible to have a program to encourage sprinklers and fire safety.
- Council should consider incorporating more clarity of two issues into the ordinance:
  - Duration of the deed restriction, and the ability to limit an ADU from being used as a short-term rental.
  - Consider if short-term rentals are best dealt with in the ordinance or on a case-by-case basis.

The motion passed 3-0.
