You are invited to attend a Planning Commission public hearing on the following project.

PROJECT DESCRIPTION

The Sierra Crew, LLC / Charles Chi, owner of 19 Toyon Lane, is requesting approval of a Design Review Permit to allow the installation of a metal sculpture and the construction of a retaining wall in the front yard of 19 Toyon Lane. The sculpture depicts a man made of mostly recycled metal components and metal grass stocks. The sculpture is approximately 13 feet tall, 7 feet wide, and 5 feet long. The retaining wall is approximate 3.5 feet high and 12 feet long.
