

CITY OF SAUSALITO NOTICE OF PLANNING COMMISSION PUBLIC HEARING FOR A DESIGN REVIEW PERMIT, TREE REMOVAL PERMIT, AND A RECOMMENDATION OF CITY COUNCIL APPROVAL OF AN ENCROACHMENT AGREEMENT AT 200 SAUSALITO BOULEVARD

You are invited to attend a Planning Commission public hearing on the following project.

PROJECT DESCRIPTION

Stephen Stroub requests City approval of the following:

- **Design Review Permit** to construct an attached two-car garage structure (412 sq. ft.) and addition (78 sq. ft.) to the existing two-unit dwelling at 200 Sausalito Boulevard, along with associated site improvements.
- Tree Removal Permit for the removal of two trees in the footprint of proposed garage.
- **Encroachment Agreement** for stairs, deck, driveway, utility meters, and walled landscaping improvements in the public right-of-way.

The project entails demolition of the existing detached garage structure (200 sq. ft.) on the property. The project is subject to Heightened Design Review.
