A. 101 CALEDONIA STREET / MARIN THEATER

summary: The following planning entitlements are requested: modification to approved Design Review Permit for exterior renovations, renewal of Conditional Use Permit for establishment of a second-level office within two years and a theater and restaurant within four years, renewal of Sign Permit for business identification signage and theater marquee, and renewal of Encroachment Agreement for an awning and exterior building materials. The Planning Commission will reconsider this project, previously approved in 2016 and 2017, to evaluate a current request for bifurcation of the overall project into two construction and implementation phases. The project has been determined to be exempt from further environmental review under Sections 15301 and 15303 of the California Environmental Quality Act (CEQA).

RECOMMENDATION: Approval, subject to conditions.
