3. Technical Specifications Section 1-10 DISPOSAL OF MATERIALS

Add additional paragraphs:

The Contract Unit Price paid per pound for **Hauling and Disposal of Regulated Asbestos Containing Material (Revocable (Bid Item 12))** shall include full compensation for hauling and disposal of regulated asbestos containing material (RACM).

The Contract Unit Price paid per ton for **Removal and Disposal of Vegetative Debris (Bid Item 13)** shall include full compensation for furnishing all labor, materials, tools, equipment, and incidentals, and for doing all the work involved in removing and disposing of vegetative debris.

Question: What is the pay item for trees and brush?

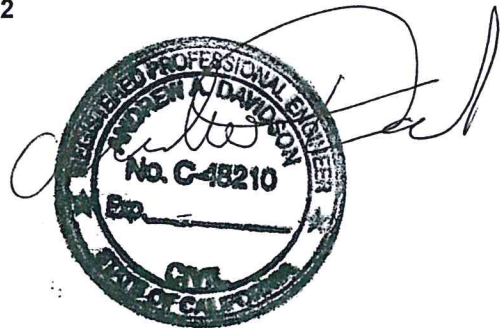
