A Sidewalk Vending Permit is required for all Sidewalk Vendors operating within the City. Stationary Sidewalk Vendors are prohibited in all Residential Zones within the City. Sidewalk Vendors are not allowed within two-hundred (200) feet of any farmers' market, swap meet, or Special Event within the City, for the duration of the event. Sidewalk Vendors are not allowed in the Downtown Area. See Sausalito Municipal Code Chapter 13.33 for all regulations pertaining to Sidewalk Vendors.

The requirement of a Sidewalk Vending Permit is in addition to the requirement for a <u>City of Sausalito Business License</u>, and any licenses or other requirements mandated by Federal, State, or local agencies, including the County of Marin Environmental Health Services Department (415-473-6907). One Sidewalk Vendor is allowed per permit.

Acceptance of a Sidewalk Vending Permit Application must be accompanied by payment of the applicable nonrefundable processing fee and does not constitute any indication of approval. Additional information may be required depending on the proposed scope of business.
