PROJECT SUMMARY: Applicant Sean Mcardle, on behalf of the property owner Dan and Julie Kauffman is requesting a

Tree Removal and Design Review Permit to remove seven (7) trees and construct additions to convert an existing single family dwelling to a duplex at 3 Marion Avenue. Projects that result in or exacerbate over 80 percent of the maximum permitted floor area and /or building coverage require Heightened Design Review. This project adds 2,147 (sf) square feet of floor area and 926 (sf) square feet of building coverage and therefore results in (.64) Floor Area Ratio and (41%) building coverage for the property as a whole. The project has been determined to be exempt from further environmental review under California Environmental Quality Act (CEQA) Section 15303.

WHAT WILL HAPPEN: The Planning Commission will consider all public testimony and decide whether to approve, deny, or modify the project. The Planning Commission may also decide to continue the public hearing, or request additional information.

HOW TO COMMENT: All persons are welcome to comment on the project. You can comment on the project via email to the project contact. The deadline to submit written comments is by **4:30 PM** on **04/21/2021**. You may also comment orally during the hearing.
