The Commission will publicize Sanitary District offer to pay 50%, up to \$1000, of the cost to repair a lateral discovered to be defective. The owner must pay for the initial video inspection.

3. Approval of the Agenda

4. M/S/P to approve the minutes of the October meeting.

5. Sausalito City Council Update:

A. Resigned/Unqualified members – Brett Van Emst and Abe Christensen have been taken off the Commission. The Commission welcomed Alix Spivack to the Commission.

B. Marin Clean Energy - The City Council will consider joining the Marin Energy Authority, MEA, at the Nov 16th meeting. MEA is to be the name of the joint powers authority formed to implement the Community Choice Aggregation, CCA, program in Marin County developed by the Marin Clean Energy organization. At issue is the decision to join MEA in time to participate in its formation, which although not certain, is certainly likely. Commissioners are encouraged to attend.

The County is funding most of the activities associated with the formation of MEA including some support for Sausalito, which has been used to study its impact on the residents of Sausalito. If all goes well, MEA will be officially formed in early 2009 and be functioning later that year.

In addition to the funded consultation, Commissioner Fortmann has been helping the City in drafting a staff report on MEA. City Manager Politzer indicated that the City is pleased with his work and commended him for his willingness to contribute to this effort.

M/S/P to notify the City Council that the Commission reaffirms its support for joining MEA. If the City Council decides to join MEA, the Commission wishes to be a major resource for the Council by studying the details of the program as it develops and by providing a qualified member, alternate or designated representative to the MEA.

- C. Green Building Ordinance The City Planning Department and Planning Commission are studying our submittal. Council Member Leone suggested that the Commission invite representatives from cities that have already passed green building ordinances or from the county to discuss their experiences and recommendations.
- D. Council Member Leone suggested that Jonathan Goldman, newly hired to the Planning Department, be invited to meet with the Commission.

6. Bay Cities Refuse Services

Commissioner Towers indicated that BCRS will now accept milk cartons for recycling. However, there is some confusion as to which types of milk cartons. The sealed non-refrigerated or the wax-coated. In any event, residents can put them in the recycle stream for final determination by the resource recovery facility. BCRS would like to discuss hazardous waste with the Commission when he next attends.

7. Public Comment. - None

8. Unfinished Business

- A. BCRS Commissioner Towers reported on a conversation she had with Greg Christie. She reported that BCRS believes that a permit for hauling compostables is not difficult to obtain. However, there is no place to take compostables in Marin or Contra Costa Counties at this time.
- B. Budget M/S/P to ask the City to pay for the Business of the Year award from our grant and to ask BCRS to use bottle-bill money to pay for the solar panes door hangers and cleaning the Wizard costume. All other action was tabled.
- C. Outreach All the door hangers were distributed. Commissioner Fortmann will ask Solar City if there were any inquiries as a result. If there have been, the Commission will likely want to continue to cover the entire city.
- D. Website Commissioner Ring indicated that he could now modify text on the website and that he hoped to expand his capability to include links in the coming month.
- E. Solar Panels on City Hall There has been a problem with the manufacturer, which is delaying the installation. M/S/P to ask the City Council to waive the street repair fees normally associated with construction and remodel project for solar panel installation. This would be in accordance with already established City policy to encourage solar panel installations by lowering fees and fast-tracking applications. Commissioner Faber will communicate with the Council.
- F. Safety Building M/S/P to delete this as an active project of the Commission.
- G. Sewer Laterals The River Watch suit has been settled with the City. The result will be more funding for the inspection and repair of laterals. It is possible that the Marin Real Estate Association might make a contribution as well.
- H. No Bottled Water Ordinance Tabled
- I. Halloween Review Tabled
- 9. New Business All new business was tabled to the next meeting.
