**NOTICE OF INTENT TO ADOPT A
MITIGATED NEGATIVE DECLARATION
177 CAZNEAU AVENUE SINGLE-FAMILY RESIDENCE WITH INTERIOR ACCESSORY DWELLING

SUMMARY PROJECT DESCRIPTION: Applicant Millard Arterberry, McCoy Architecture, Inc., on behalf of the property owner Firas Husein & Rawan Zalatimo is requesting a Design Review Permit, Accessory Dwelling Unit, Encroachment Agreement, and Tree Removal Permit to construct a five-level 2,671-square foot single-family residence with a 267-square foot interior accessory dwelling unit and 441-square foot detached garage on a 6,000-square foot upslope lot at 177 Cazneau Ave. Projects that result in or exacerbate over 80 percent of the maximum permitted floor area and/or building coverage require Heightened Design Review. This project adds 3,378 square feet of floor area and 1,941 square feet of building coverage and therefore results in .45 Floor Area Ratio and 32 percent building coverage for the property as a whole.
