PROJECT SUMMARY	Applicant Michael Rex, on behalf of property owner Loron Investments c/o Mr. Pete Petri, are requesting an approval of a Design Review Permit, Encroachment Agreement, and Minor Use Permit at 12 El Portal/690 Bridgeway for modifications to the exterior of the existing building storefronts, a new expanded outdoor sidewalk dining area for use by the restaurant. The project has been determined to be exempt from further environmental review under California Environmental Quality Act (CEQA) Section 15301 Class 1 Existing Facilities. At the meeting the Planning Commission will consider all public testimony and decide whether to approve, deny, or modify the project.
