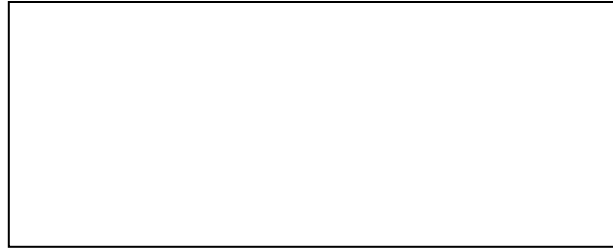

- PROJECT SUMMARY:** Applicant and property owner, Keith Stahnke, is requesting an approval of a Tree Removal Permit at 111 Bridgeway for the removal of an eugenia tree. The project has been determined to be exempt from further environmental review under California Environmental Quality Act (CEQA) Section 15304(b) Class 4 (New gardening and landscaping).
