

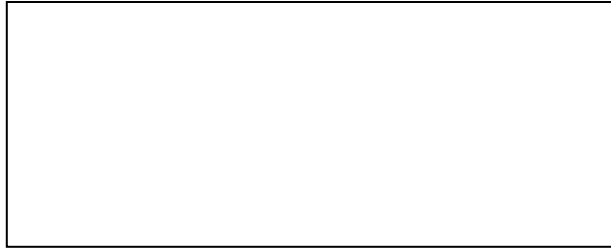

- PROJECT SUMMARY:** Applicant, Frances Seeto, on behalf of property owner, Sabrina Seeto, is requesting an approval of a Tree Removal Permit at 23 Cazneau Avenue for the removal of a diseased big-leaf maple tree. The project has been determined to be exempt from further environmental review under California Environmental Quality Act (CEQA) Section 15304(b) Class 4 (New gardening and landscaping).
- WHAT WILL HAPPEN:** The Planning Commission will consider all public comment submitted by the written comments deadline and decide whether to approve, deny, or modify the project. You will only be notified of the official action in writing if you submit written comments by the deadline.
