PROJECT SUMMARY: Applicant and Property Owner Alex Frankel is requesting approval of a Tree Removal Permit at 620 Nevada St for the removal of a Giant sequoia (*Sequoiadendron giganteum*) tree. The project has been determined to be exempt from further environmental review under California Environmental Quality Act (CEQA) Section 15304(b) Class 4 (New gardening and landscaping).

WHAT WILL HAPPEN: Applicant, Susannah Souvestre, is requesting approval of a Sign Permit at 39 Caledonia to replace the existing wall sign with a new painted wall sign that will be the same square footage and will utilize the same background as the existing sign which measures approximately 44 square feet. The project has been determined to be exempt from further environmental review under California Environmental Quality Act (CEQA) Section 15301 Class 1 Existing Facilities.
