#### 6. COMMUNICATIONS

- Staff: Community Development Director Scoble.
  - o City Council:
    - Heard an appeal regarding 719-725 Bridgeway at its November 17<sup>th</sup> meeting and denied the appeal in a 7-0 vote.
    - At its November 16<sup>th</sup> meeting the City Council directed staff to work with the Federated Indians at Graton Rancheria on a land acknowledgment policy.
  - Historic Preservation Commission:
    - Will consider a historic design review for 108 Spencer at its November 18<sup>th</sup> meeting.
    - Will also consider a historic context statement that will return to the HPC and the Planning Commission at its November 18<sup>th</sup> meeting.

- Director Scoble has spoken to the City's consulting code enforcement officer to get updates on certain projects and will be sending out letters to property owners on approximately 15 cases.
- Assistant Planner Mike Janusek has resigned from his post with the City.
- A permit services coordinator will soon being coming on board with the City.

### Commission: Chair Feller:

- Requested monthly updates on enforcement matters.
- Requested to agendize for the Planning Commission's December 1<sup>st</sup> meeting a discussion about defining how and when in the case of a tree removal an applicant is not required to install a replacement tree on their property that the value of that tree is put into whatever account the city keeps and if that money has been collected and where it goes.
- Requested a staff presentation to the Planning Commission regarding new legislation from the state, including SB9 and SB10.
- Requested an annual briefing from the Southern Marin Fire District defining new evacuation routes and an updated list of good and bad plants.

### Subcommittees:

- Objective Design and Development Standards Committee / Commissioner Junius:
  - The Commission is meeting every other week with another meeting on November 22<sup>nd</sup>. The Commission divided complex view issues into public and private views.
  - The Commission is starting to embrace the Marin County toolkit and will adopt some of its pieces.
- Housing Element Advisory Committee / Commissioner Saad and Chair Feller:
  - The Committee is newly formed with its next meeting scheduled for December 8<sup>th</sup>.
  - Principle Planner Thompson spoke about the focus group on November 17<sup>th</sup> with community organizations, social service providers, and nonprofits regarding the Housing Element Update.
- o Parklet Subcommittee / Commissioner Luxenberg and Chair Feller:
  - Had its first meeting on November 11<sup>th</sup> and discussed items that had come before the City Council and the benchmarking done by Chair Feller and Vice Chair Graef. Based on that information deliverables that will end up at the Community Development Department were outlined.
  - The next meeting will be held November 22<sup>nd</sup> and will refine what those deliverables will be.
- Sea Level Rise Task Force / Chair Feller:
  - A presentation was provided to the City Council at its November 16<sup>th</sup> meeting on the Sea Level Rise Task Force and received

City Council input on it's report's initial draft, the most important being that a full blown vulnerability study needs to be done on certain parts of Sausalito.
