B. BRIDGEWAY AT COLOMA STREET – BACKUP GENERATOR LANDSCAPE PLAN, SAUSALITO-MARIN SANITARY DISTRICT COLOMA PUMP STATION IMPROVEMENTS PROJECT (PROJECT ID: 2019-00084)

SUMMARY: A Design Review Permit, Encroachment Agreement, Conditional Use Permit, and Tree Removal Permit were approved to construct the Sausalito-Marin City Sanitary District (SMCSD) Coloma Pump Station improvements.
