**PROJECT SUMMARY:** Applicant, Tserenpuntsag Tsedendamba, is requesting a one-year extension of the approval time limit for project 2018-00276 permitting a 5,120 sq. ft. house and 1,465 sq. ft. subterranean garage on a 30,293 net sq. ft. parcel located at 99 Wolfback Ridge Road. No modification to the original approval is proposed. The project has been determined to be exempt from further environmental review under California Environmental Quality Act (CEQA) Section 15303.

**WHAT WILL HAPPEN:** The Zoning Administrator will consider all public testimony and decide whether to extend the approval without modification, as requested.
