

Grounds of the appeal of the decision of the Planning Commission decision at its September 13, 2023 meeting in regards to the Ferry Landside Improvement Project

- The Planning Commission redesign fails to “modify existing City-owned parking lot uses to better integrate the areas for vehicle, pedestrian and bicyclist uses and to improve circulation, safety, and efficiency” as required by the FTA grant.
- Makes permanent the unsafe and congested waiting and processing of ferry passengers with pedestrian and bicycle queues in the same limited space.
- Does not delineate separate areas for vehicle, pedestrian and bicyclist uses to improve circulation in this highly congested area.
- Fails to widen and improve access routes and wayfinding.
- Fails to enhance the shoreline ferry plaza promenade and significantly reduces the plaza size from the plan approved by the City Council on March 22, 2022.




