PROJECT SUMMARY: Applicant, Gary Gochberg, agent for AT&T Mobility, is requesting the approval of a Macro Wireless Telecommunication Facility with Design Review Permit, Conditional Use Permit, and Encroachment Agreement. The Permit would allow for the removal of an existing wood monopole and installation of a new mono-tree pole. The Conditional Use Permit is required per the Open Space (OS) Zoning District for new Wireless Communication Facilities. The Encroachment Agreement is for the wireless mono-tree pole to be installed and maintained on City-owned property. The project has been determined to be exempt from further environmental review under California Environmental Quality Act (CEQA) Section 15301 (Existing Facilities).

WHAT WILL HAPPEN: The Planning Commission will consider all public testimony and decide whether to approve, modify, or deny the project.

HOW TO COMMENT: Any individual is welcome to comment on the project. You can comment on the project via email to the project contact. The deadline to submit written comments is by **12:00pm** on **Wednesday, November 1st, 2023**. You may also comment orally during the hearing.
