

## NOTICE OF A PLANNING COMMISSION PUBLIC HEARING TO CONSIDER APPROVAL OF A TREE REMOVAL PERMIT TO REMOVE ONE COAST LIVE OAK TREE AND A ZONING PERMIT FOR AN 85-SQUARE FOOT ADDITION AT 626 MAIN STREET PROJECT ID: 2024-00026 | APN: 065-231-27

**PROJECT SUMMARY:** The applicant, Donald Lingeman, on behalf of owners, Jan and Elizabeth Schat, requests Planning Commission approval of a Tree Removal Permit to remove one (1) Coast Live Oak (*Quercus agrifolia*) tree, and a Zoning Permit for an 85-square foot residential addition at 626 Main Street (APN: 065-231-27). The residential addition consists of a new 73-square foot stairway addition providing access to the lower-level storage area which will be converted into living space, and 12-square feet of added interior space. The storage space will be reconfigured with the addition of a new laundry room, bedroom, and bathroom. The project has been determined to be exempt from further environmental review under California Environmental Quality Act (CEQA) Section 15303 and 15304.

**WHAT WILL HAPPEN:** The Planning Commission will consider all public testimony and decide whether to approve as requested or conditioned, modify, or deny the project.

**HOW TO COMMENT:** Any individual is welcome to comment on the project. You can comment on the project via email to the project contact. The deadline to submit written comments is by **12:00pm** on **Wednesday, April 24, 2024**. You may also comment orally during the hearing.
