

**RESOLUTION NO. 6194**

**RESOLUTION OF THE SAUSALITO CITY COUNCIL  
APPROVING THE SAUSALITO CITYWIDE HISTORIC CONTEXT STATEMENT**

---

**WHEREAS**, Congress declared in the National Historic Preservation Action that it shall be the policy of the federal government, in partnership with the state and local governments, “to foster conditions which our modern society and our prehistoric and historic resources can exist in productive harmony”; and

**WHEREAS**, the National Park Service and the State of California through the Office of Historic Preservation, California State Parks, has established a Certified local Government program to carry out this policy; and

**WHEREAS**, the program recognizes local government which have legislated a preservation program, including a qualified cultural resources commission which identifies and designates significant cultural resources to be protected for future generations and which advises the city council on actions which affect these resources; and

**WHEREAS**, on July 14, 2011, the City of Sausalito was approved by the State of California and the United States Department of Interior to be a Certified Local Government; and

**WHEREAS**, in 2012, Sausalito received a Certified Local Government Historic Preservation Fund Grant in the amount of \$12,500 to prepare a Citywide Historic Context Statement; and

**WHEREAS**, as part of the City’s continuing effort towards historic preservation and recognition of the City’s historic heritage, a Citywide Historic Context Statement has been developed and submitted to the City Council for review; and

**WHEREAS**, the City’s Historic Preservation Commission has previously reviewed the Historic Context Statement on May 20, 2021 and November 18, 2021 and recommends the City Council approve the Historic Context Statement; and

**WHEREAS**, the City’s Planning Commission has previously reviewed the Historic Context Statement on June 16, 2021 and December 15, 2021 and recommends the City Council approve the Historic Context Statement; and

**WHEREAS**, the City Council has previously conducted public meetings on the Historic Context Statement on August 31, 2021, October 26, 2021, February 8, 2022, and May 5, 2022 and considered public comment.

**NOW, THEREFORE, THE CITY COUNCIL HEREBY RESOLVES:**

**Section 1.** The City Council hereby approves the Historic Context Statement dated May 2022, attached hereto as Exhibit “A”.
