**AGENDA TITLE:** Schedule for DeSantis Appeal Hearing (DR 08-034)

### RECOMMENDED MOTION:

Schedule the public hearing on the DeSantis Appeal for the September 15, 2009 City Council meeting.

## **BACKGROUND AND DISCUSSION**

On March 18, 2009 the Planning Commission approved Design Review Permit DR 08-034 for a 125 square-foot addition and 117 square-foot porch at 46 Santa Rosa Avenue. On March 30, 2009, Julie and Edward Murphy, 44 Santa Rosa, appealed the Planning Commission's approval of the Design Review Permit. Before a City Council appeal hearing had been scheduled, the Community Development Department received a letter on April 29, 2009 from Mr. Murphy countersigned by Mr. DeSantis stating that the property owners were working on a mutually-agreeable redesign of the project that would be resubmitted to the Planning Commission for approval. Mr. Murphy and Mr. DeSantis are, in the interim, requesting that the City Council's hearing on the appeal be postponed to the last meeting in September, 2009. Mr. Murphy has stated that if a mutually agreeable solution is approved by the Planning Commission prior to the appeal hearing he will withdraw the appeal.

### FISCAL IMPACT

As you know, Julie Murphy and I have appealed the decision of the Sausalito Planning Commission concerning the above-referenced application (the "Appeal"); which decision was rendered at the meeting of the Planning Commission on March 18, 2009; and which decision concerns the design of certain remodeling of 46 Santa Rosa represented on Architectural Plans dated September 19, 2008 and submitted to the Planning Department on January 5, 2009 (the "Approved Design").

It is my understanding that, although the hearing on the Appeal was scheduled for the meeting of the City Council to be held May 5, 2009, the Planning Department has itself already postponed the hearing on the Appeal to May 26, 2009.
