Finding Priority Sewer Rehabilitation Projects 1A and 1B Categorically Exempt from the California Environmental Quality Act and Directing the Filing of a Notice of Exemption

# **RECOMMENDED MOTION:**

Adopt a Resolution of the City Council of the City of Sausalito Finding Priority Sewer Rehabilitation Projects 1A and 1B Categorically Exempt from the California Environmental Quality Act and Directing the Filing of a Notice of Exemption

# **SUMMARY**

The California State Water Resources Control Board, Division of Financial Assistance administers the State Revolving Fund loan program and is the administering entity for Federal Economic Stimulus monies for wastewater projects. In order to benefit from those monies, the State Water Resources Control Board requires that projects undergo Environmental compliant with Division of Financial Assistance Environmental Review Process Guidelines for State Loan Applicants. With Resolution 5016 of April 7, 2009 the City Council authorized the City Manager to submit an application for such funding assistance for Priority Sewer Rehabilitation Projects. Two of those projects, Project 1A and Project 1B, have been developed and the potential impacts assessed to an extent that a finding in compliance with the Division of Financial Assistance Environmental Review Process Guidelines for State Loan Applicants is timely. Project 1A involves the installation of three geotechnical borings, and repair of approximately 2,300 linear feet of existing 8-inch sewer pipes by lining with new 4-inch pipe using launch pits and pulling through the existing line, replacement of approximately 800 linear feet of 6-inch sewer laterals with new 6-inch lines and pump stations using open trenches. Project 1A will be constructed in the vicinity of Gate 5 Road between Harbor Drive and Coloma Street (see attached conceptual plan).

Project 1B involves the installation of two geotechnical borings, rehabilitation of to the Anchor Pump Station, replacement of 1,120 linear feet of existing pipe, by a combination of open trenching to replace an existing 6-inch line and pulling a new force main through existing 6-inch lines, and installation of a new small-package lift station and grease interceptor. Project 1B will be constructed along Humboldt Ave, through the Sausalito Yacht Harbor parking lot along the Bay Street alignment on Spinnaker Point (see attached conceptual plan).

Item #: 4816 Meeting Date: April 6, 2010 Page #: 1 Work at both sites will occur largely within existing trenches. Any water removed during excavation will be discharged to the sanitary sewer. Best Management Practices will be employed during construction to minimize dust and disturbance. The street will remain open with traffic controls during construction.

On the basis of the environmental analysis conducted by the City's consultant for the subject projects, Prunuske Chatham, Inc. based on project descriptions provided by the City's designer, West Yost Associates, Staff concurs that the subject projects are categorically exempt from the California Environmental Quality Act inasmuch as they both involve replacement or rehabilitation of existing facilities with no increase in capacity or expansion in use as directed.

## **ISSUES**

No outstanding issues have been identified.

## FISCAL IMPACT

No fiscal impact is associated with the contemplated action.





# A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF SAUSALITO FINDING PRIORITY SEWER REHABILITATION PROJECTS 1A AND 1B CATEGORICALLY EXEMPT FROM THE CALIFORNIA ENVIRONMENTAL QUALITY ACT AND DIRECTING THE FILING OF A NOTICE OF EXEMPTION

WHEREAS, the City of Sausalito ("City") desires to construct and/or reconstruct certain public facilities and improvements relating to its wastewater system, including pipelines, laterals, manholes, cleanouts, pump stations and other infrastructure (the "Project"); and

WHEREAS, elements of the Project, identified as "Project 1A" (in the area of Gate 5 Road between Coloma Street and Harbor Drive) and "Project 1B" (in the area of Spinnaker Point and Humboldt Avenue) have been advanced to an extent that the potential environmental impacts of said construction and/or reconstruction have been assessed in conformance with the California Environmental Quality Act ("CEQA") and California State Water Resources Control Board, Division of Financial Assistance Environmental Review Process Guidelines for State Loan Applicants; and

WHEREAS, Project 1A will involve the installation of three geotechnical borings, and repair of approximately 2,300 linear feet of existing 8-inch sewer pipes by lining with new 4-inch pipe using launch pits and pulling through the existing line, replacement of approximately 800 linear feet of 6-inch sewer laterals with new 6-inch lines and pump stations using open trenches; and

WHEREAS, Project 1B will involve the installation of two geotechnical borings, rehabilitation of to the Anchor Pump Station, replacement of 1,120 linear feet of existing pipe, by a combination of open trenching to replace an existing 6-inch line and pulling a new force main through existing 6-inch lines, and installation of a new small-package lift station and grease interceptor. Project 1B will be constructed along Humboldt Ave, through the Sausalito Yacht Harbor parking lot along the Bay Street alignment on Spinnaker Point; and

WHEREAS, the necessary environmental analysis of Project 1A and Project 1B has been made by the City's consultant for the subject projects, Prunuske Chatham, Inc. based on project descriptions provided by the City's designer, West Yost Associates; and

WHEREAS, Staff has reviewed the environmental analysis and concurs with the City's consultants that both the subject Project 1A and Project 1B are categorically exempt from CEQA (Class 1 – Section 15301 -- Operation, repair, maintenance, or minor alteration of existing structures or facilities not expanding existing uses) inasmuch as they both involve replacement or rehabilitation of existing facilities with no increase in capacity or expansion in use; and

**WHEREAS**, as the lead agency for Project 1A and Project 1B, the City is responsible for issuing a Notice of Exemption communication these findings.

# NOW, THEREFORE, BE IT RESOLVED that the City Council of the City of Sausalito:

- 1. The City of Sausalito finds that Priority Sewer Rehabilitation Projects 1A and 1B are categorically exempt from the CEQA Class 1 Section 15301 (Operation, repair, maintenance, or minor alteration of existing structures or facilities not expanding existing uses).
- 2. City Staff is directed to file the attached and incorporated by reference herein Notice of Exemption with the County of Marin and the State of California, Office of Planning and Research.

## **Description of Project:**

The City of Sausalito proposes to rehabilitate sanitary sewer facilities at two locations.

## Site 1a includes:

- Three geotechnical borings,
- Repair of approximately 2,300 linear feet of existing 8-inch sewer pipes by lining with new 4-inch pipe using launch pits and pulling through the existing line, and
- Replacement of approximately 800 linear feet of sewer laterals with new 6-inch lines and pump stations using open trenches.

# Site 1b includes:

- Two geotechnical borings,
- Rehabilitation of the Anchor Pump Station,
- Replacement of 1,120 linear feet of existing pipe, by a combination of open trenching and pulling new line through existing, and
- Installation of a new grease interceptor.

Work will occur largely within existing trenches. Any water removed during excavation will be discharged to the sanitary sewer. Best Management Practices will be employed during construction to minimize dust and disturbance. The street will remain open with traffic controls during construction.
