RECOMMENDED MOTION:

Adopt resolution calling the November, 2010 General Municipal Election

SUMMARY

By adoption of the attached resolution, Council is officially calling the General Municipal Election for November 2, 2010 and requesting that the Marin County Registrar of Voters conduct the election.

BACKGROUND

The City of Sausalito holds its General Municipal Elections in November of even numbered years. This election is for the purpose of electing City Councilmembers to four-year terms.

For many years, the City of Sausalito has requested the services of the County in order to consolidate election costs. In so doing, the City realizes significant savings in personnel time and costs associated with running a municipal election. However, in order to have the County assist with our election, the attached resolution must be adopted by the City Council prior to July 1.

FISCAL IMPACT

Costs for County services are expected to increase this year and are estimated to be between \$7,737 and \$12,895.

- 3. That the City Clerk of the City of Sausalito is hereby ordered and directed to file a copy of this resolution with the Board of Supervisors of the County of Marin.
