Vehicle Replacement

RECOMMENDED MOTION:

Approve the sale of the Police Department's 2001 right hand drive Jeep Wrangler and the purchase of a used 2006 Ford Ranger compact pickup truck from Sunnyvale Toyota

SUMMARY

The Police Department is seeking City Council approval to sell its 2001 right hand drive Jeep Wrangler and to purchase a used 2006 Ford Ranger compact pickup truck as its replacement.

BACKGROUND

In 2000, the Police Department purchased a new 2001 right hand drive Jeep Wrangler for use as a parking enforcement vehicle at a cost of \$23,600. This experiment failed and the vehicle has been rarely used except to tow the police radar trailer and place it in various locations in Sausalito. The Jeep has only 4071 miles on its odometer. The Police Department wishes to sell the Jeep and purchase a used 2006 Ford Ranger compact pickup truck. The truck has 73,073 miles on its odometer. We expect to get much more use from the truck. Not only will it be able to tow the police radar trailer when needed but it will also serve as a utility vehicle for transporting bicycles and other property and evidence from the police facility to storage. We also plan to use it to assist us in the move to the new police station in addition to other general errands and tasks after the move.

FISCAL IMPACT

The Police Department paid \$23,600 for the 2001 Jeep Wrangler in 2000. The replacement cost was paid from the police budget into the City's vehicle replacement fund over the next 6 years but the Jeep was not replaced. We have listed the Jeep for sale with one of two vendors that specialize in selling right hand drive Jeeps to rural contract postal workers. We have it listed for sale at \$12,900 but it might sell for a lesser amount.

We have selected a used 2006 Ford Ranger compact pickup truck from Sunnyvale Toyota. Its cost, including taxes, fees, and registration, amounts to \$12,357.89.

We expect the fiscal impact to be minor depending on the final sale price of the Jeep. The difference would come from the City's vehicle replacement fund.

STAFF RECOMMENDATIONS

Approve the sale of the Police Department's 2001 right hand drive Jeep Wrangler and the purchase of a used 2006 Ford Ranger compact pickup truck from Sunnyvale Toyota.

WHEREAS, the Police Department currently owns a 2001 right hand drive Jeep Wrangler that was once used for parking enforcement; and

WHEREAS, the Jeep has been rarely used and only has 4071 miles on its odometer; and

WHEREAS, the Police Department would like to sell the Jeep and purchase a replacement vehicle that will have more utility; and

WHEREAS, the Police Department has arranged to purchase, pending City Council authorization, a used 2006 Ford Ranger compact pickup truck; and

WHEREAS, the Police Department has already fully funded the Jeep's eventual replacement; and

WHEREAS, the selling price of the Jeep is expected to match the purchase price of the truck. Any difference would be paid from the City's vehicle replacement fund.

Now, therefore be it resolved, the City Council of the City of Sausalito does hereby authorize the sale of the Police Department's 2001 right hand drive Jeep Wrangler and the purchase of a used 2006 Ford Ranger compact pickup truck.
