RECOMMENDED MOTION:

Move to Adopt a Resolution declaring Certain Property Surplus and Authorizing the City Manager to Dispose of Said Property

DISCUSSION

The Sausalito Fire Department recommends the attached list of surplus property currently removed from service and being stored at the Southern Marin Fire Station 4, be declared surplus pursuant to Government Code Section 37350, "A City may purchase, lease, receive, hold and enjoy real and personal property, and control and dispose of it for the common benefit." Staff recommends that the declared surplus/refuse property be disposed of by a licensed auction group.

FISCAL IMPACT

The removal of the surplus property will lessen the financial obligation of the City by removing it from their insurance coverage and create needed space for other fire apparatus.

STAFF RECOMMENDATIONS

Staff recommends that the City Council adopt a resolution declaring certain property surplus and authorizing the City Manager to dispose of said property.


