2. **Public Comment On Items Not On Agenda - None**
3. **Approval Of Minutes – October 25, 2010**

Accessory Dwelling Units in Single Family Districts (Schinsing, Visser) – Associate Planner Schinsing indicated that the report had been distributed in the HEC packet and no written comments were received. The Committee directed Staff to distribute the report in the December 13, 2010 HEC packet to elicit additional feedback.
 - c. Vacant Land (Cox, Bair, Visser) – Associate Planner Schinsing indicated that she met with Vice-Chair Cox and Committee members Bair and Visser to discuss the vacant land task. The group has a tentative deadline of November 29th to return the survey instrument to Associate Planner Schinsing so that she can begin to work with the County to map out the vacant parcels and prepare a table showing the parcel characteristics (size, zoning, etc).
 - d. Underdeveloped Parcels/Multi-Unit Parcel Opportunities (Pfeifer, Flahive, Bair, Stoddard) – Associate Planner Schinsing reviewed the Underdeveloped Parcels methodology with the Committee.

Associate Planner Schinsing indicated that she would discuss the issue with Community Development Director Jeremy Graves.*
