CITY OF SAUSALITO NOTICE OF PLANNING COMMISSION PUBLIC HEARING FOR A DESIGN REVIEW PERMIT, TREE REMOVAL PERMIT AND ENCROACHMENT AGREEMENT AT 105 CRESCENT AVENUE DR/TRP/EA 09-184

PROJECT: The public hearing for the following project, which was originally scheduled for May 11, 2011, will be continued (a.k.a., postponed) to the Planning Commission meeting at 6:30 p.m. on Wednesday, May 25, 2011. The project, as requested, is listed below:

The applicant, John Bells, on behalf of property owners, Al and Bettie Troupe, is requesting Planning Commission approval of a Design Review Permit for the construction of a new single-family residence at 105 Crescent Avenue (APN 065-222-50), as well as a Tree Removal Permit to remove 43 protected trees located on site, and an Encroachment Agreement to construct a portion of the driveway and driveway apron in the Crescent Avenue public right-of-way. This project requires heightened review as it proposes to exceed 80% of the permitted Floor Area Ratio limitations.


