Public Hearings

1. TRP 11-019, Tree Removal Permit, Hales, 640 Sausalito Boulevard. Tree Removal Permit to remove four protected trees at 640 Sausalito Boulevard (APN 065-163-01). A Nonconformity Permit was approved on April 13, 2005 for the remodel of the existing residence at 640 Sausalito Boulevard.

The public hearing was opened. Assistant Planner Thornberry-Assef presented the Staff Report.

The public comment period was opened. Being none, the public comment period was closed.

Presentation was made by Stan Hales, the applicant.

Commission questions to Ray Moritz, consulting arborist:

• The arborist's report contains trees to be removed, such as Tree 4A, that do not have Protected or Heritage status and are not the subject of this application. Why are they in the arborist's report? Mr. Moritz responded that when visiting a property he looks at all the trees that might need protection or might be an issue during construction. Tree 4A, a plum tree, is covered with vines and is close to the house, which is why it is mentioned in the report and is suggested to be removed because it is in decline.

- Is there any way that Tree 4 could be preserved with the construction that is proposed? Mr. Moritz responded no, it is currently extremely close to the retaining wall and the work to be done within that zone would have too great of an impact on the tree's root system.
- Would the construction impact on Tree 4 be greater than the impact that already exists with the existing retaining wall? Mr. Moritz responded the retaining wall limits the root zone of the tree, but construction would be so close it would be impossible to preserve the tree so that it would have good longevity. It would be better to remove the tree and replace it.

The public hearing was closed.

Commissioner Graef moved and Vice-Chair Keegin seconded a motion to approve a Tree Removal Permit for 640 Sausalito Boulevard. The motion passed 5-0.
