**PROJECT DESCRIPTION** The applicant and property owner, Scott Foote, is requesting Planning Commission approval of a Design Review Permit for the retroactive approval of the 119.4 square foot expansion of a second floor deck (APN 065-231-02). The project was determined to require a Design Review Permit pursuant to Zoning Ordinance Section 10.54.050.B.4(c) as it has the potential to impair views from other properties.


**MEETING DAY/TIME** July 6, 2011 at 6:30 P.M.
